### Message from the Chief



#### To the Aylmer Police Services Board and the citizens of Aylmer

I have the honour of presenting my third annual report outlining the activities and services performed by the men and women of the Aylmer Police during 2012.

2012 marked the 125<sup>th</sup> anniversary of the Town of Aylmer. To celebrate our history we took the opportunity to redesign our existing police crest. We bannered our establishment in 1887 under the town crest, surrounded it with federal maple leafs, and tied it together with a provincial trillium. The Aylmer Police now proudly display this new logo on our uniforms, police cars, and building.

This year also marked the completion of our three year Business Plan cycle. The achievement of many of the goals and objectives met community expectations and reinforced public safety. Results of that plan are reported in detail within this report. The next planning cycle began in November with a community survey. That survey again provided Aylmer Police with an 85% satisfaction rating from the respondents.

Enforcement activities increased this year including R.I.D.E. programs noting a decrease in impaired driving offences. The police budget came on target but did not require the planned use of \$36,000 from reserves. Those savings have been moved forward to 2013 helping reduce that budget without compromising services to our community.

July marked the passing of former Deputy Chief Wayne Lamoure who retired in 1999. His loss was mourned by the police community and the Air Cadets of St. Thomas where he volunteered.



The officer continuously assesses the situation and selects the most reasonable option relative to those circumstances as perceived at that point in time.

## A total of three (3) Use of Force Reports were submitted in 2012 as per Provincial Regulations and Aylmer Police Policies and Procedures.

- Two Reports were for destruction of animals and one was submitted for a suspect arrest.
- Firearms were deployed on two occasions. Pistols were deployed for each of those occasions.
- Long guns (rifle or shotgun) were not deployed operationally during 2012.
- Firearms were discharged on two of those occasions for animal destruction.
- Firearms were not required during any arrests during 2012.
- CEW, or more commonly referred to as a Taser, was deployed on one occasion. The CEW was armed, demonstrated, and discharged. Deployment occurred during a criminal offence arrest of a non-compliant combative individual.
- OC, or more commonly referred to as Pepper Spray, was not required or deployed during 2012.
- Expandable Baton was not deployed during 2012.

## OFFICE OF THE INDEPENDENT POLICE REVIEW DIRECTOR



### Municipal Freedom of Information and Protection of Privacy Act (MFIPA)

The *Municipal Freedom of Information and Protection of Privacy Act* provides citizens with a right of access to records within the custody or control of all municipal public sector organizations, including Police Services. Access to these records is not absolute. There are certain mandatory and discretionary exemptions, which are applied. Details about the operation of the *Act* and interpretations of the 10 exemption provisions can be found at the website of the Office of the Information and Privacy Commissioner (the IPC) <u>www.ipc.on.ca</u>. The Aylmer Police routinely processes requests from the public for access to records either of a personal nature or information in general. Civilian Administrator Erica Campbell is designated as the primary FOIA officer. Sergeant Michael Knight is also designated as an FOIA officer.

The Aylmer Police processed **twenty-two requests in 2012.** Four were requested by the Office of The Children's Lawyer, three were requested by Family and Children Services and 15 general requests. Twenty-One were processed with disclosure provided to varying degrees. One was processed as "No File Exists".



### **Auxiliary Constable Program**

The Aylmer Police continues to incorporate the Auxiliary Unit to complement its staffing numbers. Auxiliary members completed a total of 208 hours which included assisting in general patrol, night football games, parade duties, maintaining security at crime scenes, guarding prisoners, providing guided station tours, assisting with Police Week Open House and displays, as well as helping with the Annual Torch Run for Special Olympics.

This past year, Aylmer Auxiliary members once again completed training alongside the Auxiliary Unit of the Elgin OPP. Sergeant Nick Novacich and members of the OPP facilitated the training. This consisted of Defensive Tactics, Arrest Authorities as well as familiarization in the use of the Aylmer Police issued Glock pistol, and shotgun. Under the Police Services Act, in extreme cases, Auxiliary Officers may be issued a shotgun under the direction of a Police Officer. Sergeant Nick Novacich continues to oversee the unit.



This Auxiliary Unit has an authorized strength of (5) members. This past year saw the resignation of member Todd Firby. (3) Members remain, Shane Hodgetts, Mike Milmine and Jason Hedges. A competition for (2) new members was initiated in May with hopes of the new members being appointed in early 2013.

The Aylmer Police continues to be a member of the Auxiliary Co-Ordinators Committee. These meetings have allowed Aylmer to network with other Auxiliary Units and enjoy the opportunity to expand on training and operational issues. Participation also allows for standardizing the Unit with the rest of the Police Services within the Province. The Auxiliary unit has once again

proven to be an invaluable resource for the Aylmer Police.

St. Thomas Crime Stoppers, working in conjunction with the Aylmer Police, are one of **38** programs in Ontario. As a member of the Ontario Association of Crime Stoppers, and Crime Stoppers International, our program is proud to represent this community in the global fight against crime and terrorism. This non-profit organization gives each and every citizen the right to provide information regarding criminal activity anonymously, without fear of retribution. Crime Stoppers guarantees that a tipster will never have to reveal their identity or testify in court.

Aylmer resident **Patricia Wilson** joined the board this year offering local representation and support. Fundraising events in 2012 included a rain barrel sale in April and the Fourth Annual Golf Tournament in May at the St. Thomas Golf and Country Club. The tournament raised over **\$6,000** and is growing every year. The annual "Bail or Jail" was held at Geerlink's Home Hardware in September. The community came through once again by jailing family, friends and co-workers. The efforts and good spirit of their prisoners raised over **\$12,000**.

The **\$5 million** Wal-Mart fire was solved with help from Crime Stoppers in 2012. To date, since inception, our local Crime Stoppers has accomplished the following;

- \$150,730 in total rewards paid
- 845 arrests
- 1069 cases closed
- \$8,479,160 in recovered property
- \$7,322,002 in recovered narcotics

2012 marked the **26<sup>th</sup> Anniversary of the Ontario Special Olympics and the 25<sup>th</sup> Anniversary of the Law Enforcement Torch Run (LETR)**. The success and support of the Law Enforcement Torch Run over the years has been phenomenal. Since its inception in 1987, the Torch Run has seen a dramatic increase in registration of Special Olympians and since the torch began its partnership with Special Olympics Ontario, the number of registered athletes has grown from under 4,000 to greater than 16,000 athletes today.

The **Ontario Special Olympics** provides athletes who have a disability with the opportunity to experience and succeed in a sport. Special Olympians gain self-confidence and transfer the success from the playing field to become more active citizens in society. The Torch Run involves Law Enforcement

personnel, who attempt to raise funds and awareness for Special Olympics in Ontario.

The run took place on May 17<sup>th</sup>, 2012 with the Special Olympians running to each of our schools in Aylmer ending at East Elgin Secondary. 2012 was also the 50<sup>th</sup> anniversary of the Ontario Police College. 200 OPC students met at the high school to help run the Torch through Aylmer.






The Aylmer Police, along with the generous support of our community, were able to raise over \$3,700.






## **Calls for Service**

Aylmer Police provide police coverage and dispatch services 24 hours a day. The station is open to public Monday to Friday 830am to 430pm. On nights, weekends, and holidays, the dispatch service is contracted to St.Thomas Police. Both agencies use the same data software, and as such, all Aylmer Police calls for service are integrated into the same provincial database. Computer Aided Dispatch (CAD) and Records Management System (RMS) are the two databases used. CAD calls are generated when the public call police for assistance. RMS calls are self generated after the fact and often include traffic enforcement and community service. Peak times for service are seen in the graphs below and consistently occur in the middle and the end of the week. This data only reflects the number of calls, not the types. This also tends to represent when the calls are *received* as opposed when the incident *occurred*.

In 2012 there were **2992 CAD** calls and **718 RMS** incidents for a total of **3710**. The average over the 3 years is **10 calls / incidents** per 24 hour period.
