The following comments were received from Penny Tolmie, Business Plan Committee Member:

P. Tolmie states that she believes the 2013-2015 Business Plan is the best compiled plan to date. It covers many challenges the service faces such as drugs, bullying etc. It would be helpful for the service and planning for future needs if the community would provide feedback on this document.

It is noted that the Plan for 2013-2015 was adopted by Resolution # 23-13.

A. Reymer notes that there has been a delay in appointing Board Members, however they hope to have this taken care of in the very near future. It has been recommended that we send a letter asking that the Minister be allowed to confirm Mr. Forsdike's re-appointment until the Lieutenant Governor can sign the required documents. The Board is in favour of forwarding correspondence in respect to a bridge appointment for Mr. Fordike's re-appointment to the Board.

# 8. Reports

a) Detailed Trial Balance

No large purchases to date, except the vehicle which is not be reflected in these reports.

b) Detailed Budget Report (Police, PSB, Capital)

We advertised for a duration of 4 months for officers and only received 20 applications.

As previously mentioned we ordered the new vehicle (Explorer) and it should be here within 2 weeks, it is an all wheel drive vehicle. Although it was more expensive initially it will have a longer life, it will also provide move space for the officers with all of the gear that they must wear.

We have spent 66% of the budget to date with no major concerns.

The PSB budget is on target. We did not buy a lot of promotional items for Doors Open this year; however we did have approximately 130 persons participate.

c) Quarterly Police Report

We had our first public complaint in three years, which has now been cleared.

There will be some changes coming forward regarding the use of tazers for front line use. We will ensure the proper training is done, but we may need to buy more devices.

Enforcement up is up 25% over last year, cell phone use is still occurring.

School lectures include topics such as; bullying as well as cyber bullying.

We investigated a complaint about a high school student trafficking to middle school students.

Bike patrol is going well, the bike was donated to the service and is equipped with lights.

d) Chief's Report

Attended a meeting in August to review the progress of the St. Thomas Court House. Participated in a meeting for the Aylmer splash pad.

Attended a meeting in July with Victim Services, they explained the services that their organization provides.

The Canadian Mental Health Association do have personnel that go to residents homes to provide assistance when required.
