- 6. Unfinished Business
  - a) Records Retention

Samples have been collected more to be received, a draft will be prepared for Board review.

- 7. New Business
  - a) 2013 Budget

Currently the increase for 2013 is 3.14. A. Reymer notes that he prefers to see the cost per household in calculations rather than the cost per capita.

A discussion takes place on the officer population ratio.

It is noted that the funds that are received through the municipal partnership program go back to the Town but not put into the police budget.

Chair D. LaPointe states that in this economical climate the training budget for officers needs to be decreased. He seeks support in cutting back on training that is not mandatory through legislation.

A. Reymer will review the courses for next year and provide a reduced amount for this line item It is noted that the courses are local which will help keep the cost down.

Chair D. LaPointe also proposes reducing the Boards training account.

A discussion takes place on the possible reduction of the legal fees account to \$5000.00.

It is the consensus of the Board that J. Forsdike and A. Anderson meet with the Chief to discuss the 2013 proposed budget.

- 8. Reports
  - a) Detailed Trial Balance

On target, big increase in revenues for 2013.

A discussion takes place respecting the financial aspects of the police station noting that the structure itself is the responsibility of the Town and the content would be the responsibility of the police budget.

A. Reymer notes that he is still reviewing the possibility of an alternative dispatch service and is looking at what type of connections would be required.

b) Detailed Budget Report (Police, PSB, Capital) No major concerns noted.

c) Quarterly Police Report

There has been an increase in crime stoppers reporting, we have received a lot of drug complaints. The website is now up and running.

We have had a lot of foot beat at the schools with zero tolerance where drugs are involved. The R.I.D.E program is on target. We had over 70 visitors at the station during the Doors Open event this year.

Officers have taken training in assault and human trafficking.

Received 26 - 911 calls which is fairly typically, very few are legitimate.

We have not received an engineering report on the station as of yet.

A. Reymer reviews his report noting that the surveys for the business plan are coming in.
