c) Quarterly Police Report

We did 3 R.IDE programs in May, with 7 to date, 2 of these were provincially funded. As of June we had 68 school visits. Foot beat doubled from last year.

Use of force with the OPP we contribute an officer on range, now that officer is trained to OPP standards for rifle, pistol, shotgun and tazar.

A discussion takes place respecting the REID system, this is a private company from the US, it is training on a method of investigation and interrogations, we hope to have everyone trained eventually, however it is only offered once a year.

A. Anderson states that it theory based as the training is governed by US laws and must be put into practice using Canadian law.
