#### 5. Delegation

D. Mennill, Mayor and M. Casavecchia-Somers, C.A.O./Clerk

Township of Malahide representatives re: Police Costing

Mayor D. Mennill notes that they require very similar service criteria to what they currently have under O.P.P. contract. They would expect to pay in the same range for this service with no upfront costs.

A. Reymer states that as the Township covers an area of 200 square kilometers from Crossly Hunter Line down to Port Bruce. There would be some additional personnel required as well as infrastructure such as radio towers and other equipment.

Once a costing is prepared it would require Board review then it would go to Town Council and then to Malahide for consideration. There would need to be a buffer in case something major happened in either community. Aylmer would require a long term commitment from Malahide if the proposal is accepted. Mayor D. Mennill concurs that it cannot be a short term contract but could perhaps have a 3 year revolving renewal built in.

Mayor D. Mennill asks about a time frame to receive a quote.

A. Reymer states that several months would be required to review cost implementation, towers, may need to sign agreement with the Fire Department, deal with external vendors etc. Hiring would be another consideration; we would need a long term contract to attract quality applicants. We would likely have some information within a 6 month time frame.

It is noted that it will be within an election year, and there is a potential for new Councils for both communities.

Mayor D. Mennill states that they would need adequate time to notify O.P.P. should they decide to end their contract with them.

A. Reymer notes that the O.P.P. would still be required by law to assist in certain circumstances as we back each other up. We do maintain a good working relationship with them which includes joint training. There will be further discussion forthcoming; Mayor D. Mennill and M. Casavecchia-Somers depart at this time.

#### 6. Unfinished Business

a) Malahide Police Costing

We will also need to work with Spectrum and the Fire Department regarding the communications system. Discussions with the C.A.O. will continue as there will be additional Human Resources requirements which will impact the Town's resources.

#### 7. New Business

a) Draft Budget for 2018

A. Reymer states that there will be an increase to the benefits, OMERS should stay the same, but there are still other unknowns at this time. The budget includes a purchase of a cruiser but we would keep car #15 as a transport vehicle with options of being a response vehicle. Dispatch has increased by 3%, require new hardware for Board, the figures provided are just estimates at this time.

b) Chief of Police – Hiring Recommendation for Part-time Constable

Moved by Greg Currie seconded by Sheri Andrews Resolution 97-2017

That the Aylmer Police Services Board approves the hiring of Christopher D. Perrin as a part-time Constable.

A. Reymer clarifies that the start date will be dependent upon the availability of the Use of Force training session but should be before the end of October.
